CLOSURE OF SOUTH SIDE FOOT OVER BRIDGE AT MARINE LINES STATION W.E.F 15th FEBRUARY, 2023

By Shrikant Khuperkar Marine Lines South Foot Over Bridge (FOB) connects Platform No. 2/3 and 4 at south side and is also directly connected to Marine Lines ROB from which passengers enter the station. This FOB is being dismantled and a new FOB will be rebuilt at the same location. According to a press release issued by Shri Sumit Thakur - Chief Public Relations Officer of Western Railway, the Marine Lines South Foot Over Bridge has completed its codal life and in order to undertake the dismantling and rebuilding work, the FOB will be closed for public use from 15/02/2023 to 30/11/2023. It is further informed that to interchange between PF No. 4 to PF No. 2/3 or vice versa, passengers can use the other two FOBs at Marine Lines station, i.e. Middle and North side FOBs. For passengers entering from Marine Lines ROB, an opening will be provided at PF No. 1 where passengers can enter the station or passengers can use the staircase from ROB near PF No. 4 to enter the station at PF No. 4.

Kalyan: An accident took place today in the Thankarpada area of Kalyan West in Kalyan Dombivli municipal area where the safety guard-rail on the upper floor of a two-storied chali collapsed. Fortunately, there was no loss of life and a potential accident was averted. The incident occurred on Wednesday when part of the protective stone wall of the upper floor of Durga Trishul, a 30-year-old structure in Chaliwaja area of Thankar Pada area of Kalyan West, collapsed. No one got hurt in this. It was fortunate for the resident that possible loss of life was avoided. "B" Ward Assistant Commissioner and "C" Ward Assistant Commissioner were contacted regarding this and they said that we have not received any complaint regarding this accident. हृदयरोग निवारणासाठी...

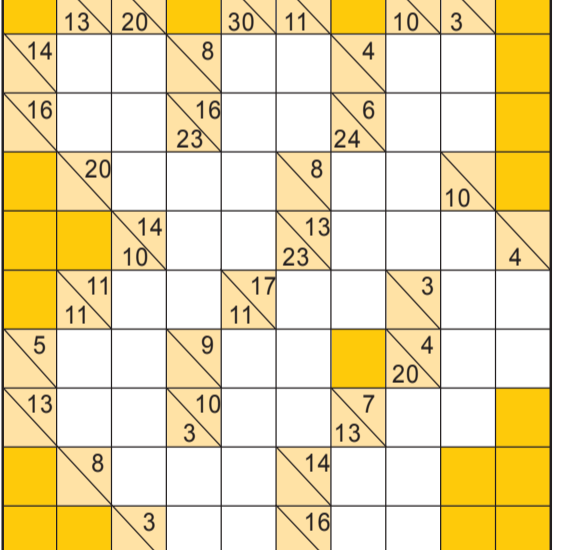
मोदक इन्स्टंट

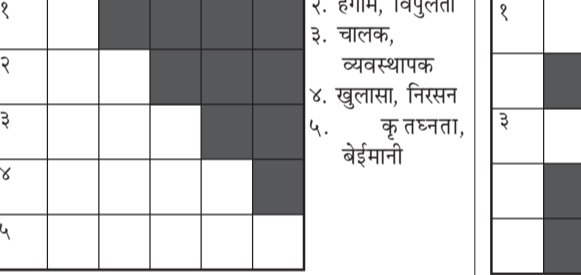

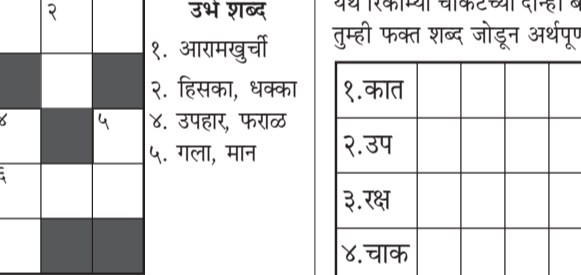
